SECTION 103-229 PERMITS.

(e) **PERMIT FEES**

(2) Permit fees shall be based upon the physical value of the work to be done as determined by the Fire Department – Division of Fire Prevention and Building Safety on the basis of current costs in the amount established by resolution.

<u>Valuation of Work</u>	<u>Fee</u>
Up to 2,000	\$30.00
2,001 to 5,000	\$30.00 + \$20.00 for each additional \$1,000.00 or fraction thereof
5,001 to 10,000	\$120.00 + \$14.00 for each additional \$1,000.00 or fraction thereof
10,001 to 50,000	\$190.00 + \$6.40 for each additional \$1,000.00 or fraction thereof
50,001 or greater	\$400.00 + \$12.00 for each additional \$1,000.00 or fraction thereof
New Sewer Connection	\$40.00
Sewer Relay	\$32.00
New Water Connection	\$40.00
Water Relay	\$32.00

- (4) In addition to the permit fee, for all additions or alterations, **record maintenance fees** are required as established by resolution.
- a. 1- and 2-family and multifamily dwellings \$10.00 each unit
 - b. Commercial and industrial buildings \$20.00
