

## **Proof of Residency and**

### **Voter Registration Changes**

Anyone registering to vote **MUST** provide proof of residency, no matter when you are registering to vote. Examples of proof of residency include: Wisconsin Driver License or ID, utility bill, bank statement, paycheck, government documentation or lease with your name on it at your current address. You must have resided at your address for 10 consecutive days to be eligible to vote. If you have not resided at your current address for at least 10 consecutive days, you must vote at your previous polling place.

# **Changes to Wisconsin Voter Photo ID Law**

Effective Immediately

## **WHAT CAN I USE AS PHOTO ID TO VOTE?**

You will not be able to cast a ballot until you show one of the following forms of photo ID. The photograph must reasonably resemble the elector and the elector's name must conform to the name on the poll book and have an expiration date as described below.

**An Acceptable Photo ID for voting does not have to include a current address.**

### **Acceptable forms of Voter ID**

#### **Expiration date must be after last general election**

- \* Wisconsin DOT-issued driver license or photo ID Card
- \* U.S. passport or card
- \* Military ID card
- \* Military Veteran Affairs ID
- \* Certificate of Naturalization issued not earlier than two years before date of election
- \* Unexpired Wisconsin driver license or State ID receipt issued by Wisconsin DOT
- \* ID card issued by a federally recognized Indian tribe in Wisconsin
- \* Unexpired or Expired ID issued by a Wisconsin accredited University, college, or technical college – must contain issuance date, student signature, and expiration date within 2 years of issuance & proof of enrollment

## **WHAT WILL THE POLL WORKERS BE LOOKING AT ON MY PHOTO ID?**

- \* **Elector's Photograph** – the photograph must reasonably resemble the elector
- \* **Elector's Name** – the elector's name must conform to the name on the poll book
- \* **Expiration** - if the ID has an expiration date, it must meet the requirements above

**You are still required to state your full name and address to the poll workers.**

## **ARE THERE ANY PHOTO IDS THAT CANNOT BE USED FOR VOTING?**

- \* State or Federal government employee IDs
- \* Out-of-state driver license or ID card
- \* Employment ID
- \* Membership or Organization ID
- \* Certificate of Citizenship

### **Absentee Ballot Requests**

Absentee requests for ballots sent by mail or e-mail must be accompanied by a photocopy of an acceptable form of voter ID (see list on the left).

Once you have sent a photocopy of your ID to your Municipal Clerk's Office, you will not need to send photocopies with future absentee ballot requests as long as you have not changed your name or address.

### **Photo ID Exemptions**

Photo ID is not required for the following absentee voters:

- Voters on the permanent absentee list because they are indefinitely confined
- Residents of nursing homes and other designated care facilities who have their ballots delivered by a Special Voter Deputy
- Military and permanently overseas voters
- Confidential voters

**Contact your Department of Motor Vehicles service center for more information on obtaining a free ID for voting.**

If you are eligible to vote but do not have a Wisconsin driver license or ID card, you may obtain a **free** ID for purposes of voting from the DMV. We recommend applying for an ID as soon as possible. You will not receive the ID immediately, it will be sent to you in the mail.
